

## PHOTOGRAPHING, FILMING AND RECORDING STUDENTS' POLICY 2024



### Help for non-English speakers

### Purpose

To explain to parents/carers:

- how Example School collects, uses and discloses photographs, video and recordings of students
- when parent/carer consent is required before photographing, filming and recording students
- how consent can be provided and withdrawn.

### Scope

This policy applies to the general collection, use and disclosure of photographs, video and recordings (images) of students.

The policy does not cover the:

- use of Closed-Circuit Television (CCTV). The use of CCTV is covered in the department's CCTV in Schools Policy.
- use and disclosure of photographs, video and recordings of adults. School staff should refer to the Photographing, Filming and Recording Staff and Other Adults Policy.

### Policy

There are many occasions during the school year where the Jacana School For Autism staff photograph, film or record students participating in school activities or events, for example: classroom activities, sports events, concerts, productions, excursions, camps etc.

We do this for many reasons including to celebrate student participation and achievement, showcase learning programs, document a student's learning journey/camps/excursions/sports events/production, communicate with our parents/carers and school community in newsletters and on classroom blogs, SeeSaw, social media apps, school year book, school website etc. There may also be occasions where we take images to support student behaviour management or to fulfil legal obligations. Further detail is provided within this policy.

In addition to the above, there may be situations where a third party requests to take, use or disclose images of students.

This policy outlines the practices that Jacana School For Autism has in place for the collection, use and disclosure of images of students to ensure compliance with the Privacy and Data Protection Act 2014 (Vic). It also explains the circumstances in which we will seek parent/carer consent and how consent can be provided and withdrawn.



## Details

Principals must:

- advise parents or carers when photographs, films or other recordings of students are to be taken and how they will be stored and used.
- provide parents or carers with the choice to withhold or withdraw consent for their child to be photographed or filmed in certain circumstances.
- manage how and when others collect and publish photographs and, or film of students.
- obtain parent or carer permission before student photographs, films or other recordings are made publicly available.
- consider whether to allow parents or carers to photograph or film their children participating in school events or performances.
- ensure that when engaging a professional photographer, a confidentiality clause relating to appropriate information handling is included in the agreement or contract between the photographer and school.

## School Level policy

Schools must develop a policy about photographing and filming students. This policy should include information about:

- whether the school arranges for individual and classroom photographs to be taken each year and if so, detail the notification, consent and publication procedures and protocols the school will follow
- the collection, use and disclosure of other school photos, video, film and digital images that may be taken by the school from time to time.
- the ways in which the school will manage requests from the media to take photographs and film of the students, including the notification, consent and publication procedures and protocols that the school will follow.
- whether the school permits parents or carers and students to record school performances and other school approved activities
- a reference to the school's CCTV policy, if the school has CCTV on the premises.
- the school's management of the collection, use and disclosure of photographs, video, film, and digital images by third parties.

The school-level policy must be made available on your school website, or otherwise be easily accessible to all parents or carers and should be communicated to parents or carers at least once a year.

## Consent

The Photographing, Filming and Recording Students Consent Form is provided by Jacana School For Autism at enrolment. This form applies to standard uses of images for the time your child attends the school. Standard uses are defined in the following sections.

For non-standard uses, where consent is required, parents/carers will be sent a consent form for that specific situation. Schools will also notify parents when implementing software that may include photos of students, giving parents an opportunity to discuss any concerns or preferences.

If at any time parents/carers wish to withdraw their consent, they can by contacting Jacana School For Autism. If consent is withdrawn verbally, the school will make a written record of this.

However:

- if the images have already been published and are in the public domain, it may not be possible to remove them
- the school can still collect, use and disclose images in circumstances where consent is not required (see below for more information).

### General school collection

During the school year, there are typically many occasions and events where school staff may photograph or film students participating in school activities and events. These images are used for a variety of purposes including school newsletters, blogs (for example, of classroom activities or camps and excursions), student identification and display in school classrooms. Schools also arrange for official school photographs to be taken each year.

The Annual Consent Form, “Photographing, Filming and Recording Students”, will include information about the storage of these photographs on CASES21 and any other proposed uses of the individual photograph. The form must be provided to parents or carers annually, preferably at the beginning of each school year.

Parents or carers can withdraw consent for their child to be photographed or filmed in certain circumstances, by contacting the school.

### Image use within the physical school environment

Jacana School For Autism may photograph, film or record students to use within the physical school environment, including:

- for display in school classrooms (e.g. in displays of student work, on noticeboards to celebrate achievements)
- on staffroom noticeboards or offices that require support or first aid needs to support the student’s health, safety
- to capture and share students' learning journeys, including camps, excursions, sports events, and productions, newsletters, SeeSaw, social media apps, school yearbook, school website etc.

A Photographing, Filming and Recording Students Consent Form will be given to parents/carers on enrolment for the standard uses described above. Consent, if given, applies until it is withdrawn or changed. If a parent/carers would like to withdraw or change their consent at any point in time, they must notify the school.

### Image use within the school community

Jacana School For Autism may photograph, film or record students to use within the school community, including:

- in the school’s online communication, learning and teaching tools (e.g., emails, classroom seesaw, apps that can only be accessed by students, parents/carers and school staff with passwords.)
- internal notices, internal staff bulletin, yearbook

- a “Photographing, Filming and Recording Students Consent Form will be given to parents/carers on enrolment for the standard uses described above. Consent, if given, applies until it is withdrawn or changed. If a parent/carer would like to withdraw or change their consent at any point in time, they must notify the school.

### Image use beyond the school community

Photographs, video or recordings of students may also be used in publications that are accessible to the public, including:

- on the school’s website
- school newsletter which is publicly available on the website
- on the school’s social media accounts [incl. public and/or restricted to certain groups, e.g. staff, students, parents/carers/the school’s online community, social media supporters]

A Photographing, Filming and Recording Students Consent Form will be given to parents/carers on enrolment for the standard uses described above. Consent, if given, applies until it is withdrawn or changed. If a parent/carer would like to withdraw or change their consent at any point in time, they must notify the school.

We will notify you individually if we are considering using any images of your child for specific advertising or promotional purposes.

### Media

The media, or the Department of Education’s media team, may seek to photograph, film or record students for a news story or school event. This may include broadcast media, online or social media or print media, including newspapers and magazine publications.

When Jacana School For Autism receives such requests, our school will:

- provide parents/carers with information about the organisation involved and when and for what purposes the photography, filming or recording will occur
- seek prior, express parent/carer consent in writing.

Students will only be photographed, filmed or recorded by the media at school if express consent is provided for that specific media event. Neither the school nor the department own or control any photographs, video or recordings of students taken by the media.

### Research

On occasion, the school may agree to research projects being conducted at the school. If this occurs, parent/carer consent will be sought for student participation, including any photography or recording of students.

## Closed Circuit Television (CCTV)

Parent or carer consent is not required for a school to install CCTV.

However, Jacana School For Autism will inform the school community of the intention to install a CCTV through (appropriate channels such as: a newsletter article; a statement on the school website; posted material within the school grounds). Our school's CCTV system is managed in accordance with the department's [CCTV Installation and Management Policy](#). Further information about how CCTV is managed and operated is available in our CCTV Privacy Notice.]

## Other external collection, use or disclosure

If there is a situation which will involve the collection, use or disclosure of images of students by or to third parties which is not otherwise covered by this policy, Jacana School For Autism will:

- provide parents/carers with information about the event or activity, the organisation involved and when the photography, filming or recording will occur
- seek prior, express parent/carers consent in writing.

## Official school photographs

Each year Jacana School For Autism will arrange for a professional photographer to take official school photographs of students. This will generally involve both class photos and individual photos being taken.

Official school photographs may be:

- purchased by parents/carers
- used for school identification cards and student identity verification letters
- stored on CASES21 for educational and administrative purposes.

Jacana School For Autism will notify parents/carers in advance of the official school photographs being taken to give them an opportunity to decide whether their child will be included in the photographs.

Parents/carers who choose to opt out of having their child participate in official school photographs must contact Jacana School for Autism before the date photos are scheduled to be taken to advise that their child will not participate. There is no obligation on any parent or carer to purchase any photographs taken. However, the school will need to discuss with these parents/carers alternative arrangements for identifying students in emergencies and for other essential purposes.

## Images to manage student behaviour or fulfil our school's legal obligations, including child safety

On occasion, it may be necessary for school staff to photograph, film or record students and/or use images to:

- fulfil legal obligations, including to:
  - take reasonable steps to reduce the risk of reasonably foreseeable harm to students, staff and visitors (duty of care)
  - provide a safe and suitable workplace (occupational health and safety law)
  - supporting students' social and emotional wellbeing, and health (duty of care)
- for identification purposes, when necessary to implement discipline and/or behaviour management policies.

Jacana School For Autism does not require or obtain consent from parents/carers or students to photograph, film or record students, or to use these images, for these reasons. However, when Jacana School For Autism photographs, films or records a student for any of these purposes, staff will only collect and use such images in a way that is necessary, reasonable and appropriate in the circumstances.

### Child Safe Standards

Jacana School For Autism will use student images reasonably, appropriately and sensitively, consistent with our obligations under the Child Safe Standards and our school's Child Safety and Wellbeing Policy. If at any time a parent/carer or student has a concern about the use of any images they should contact the Principal of Jacana School for Autism.

### Curriculum-based activities

Photographs, film and recordings of students may be collected and used for curriculum-based activities (i.e. class work) as part of standard learning and teaching practices. Jacana School For Autism does not require or obtain consent for this. Access is limited to students and relevant teaching staff. Parents/carers may have access to images of their own child in this context.

### Professional development

Occasionally, teachers and classes may be recorded for professional development purposes to improve the delivery of educational services. Jacana School For Autism does not require or obtain consent for this, however the recordings will only be used internally and for the specific purpose of staff development.

### Storage of images

Photographs, video and recordings of students taken by Jacana School For Autism will be stored in our secure document storage systems with restricted access. Any photographs, videos or recordings made on devices, including non-school issued devices, will be transferred to secure school systems and removed from the devices as soon as reasonably possible.

## Images taken by the school community

Jacana School For Autism endeavours to respect the privacy of all members of our school community and requests that parents/carers, students and invited guests do not photograph, film or record school performances, sporting events and other school-approved activities.

Jacana School For Autism requests that parents/carers, students and invited guests who do photograph, film or record school activities only do so for their own personal use and do not publish the images in any form, including on social media, without the prior consent of persons whose children also appear in the images.

Neither the school nor the department own or control any images of students taken by parents/carers, students or their invited guests at school activities.

- An annual reminder in our school newsletter
- Available publicly on our school's website
- Included in staff induction processes and staff training
- Included in staff handbook/manual
- Discussed at staff briefings/meetings, as required
- Included in transition and enrolment packs
- Hard copy available from school administration upon request

## Photographing, Filming and Recording students JACANA SCHOOL FOR AUTISM Annual Consent Form and Collection Notice

### Consent Form

There are many occasions during the school year when staff photograph, film or record students participating in school activities or events. We do this for many reasons including to celebrate student participation and achievement, showcase learning programs, document a student's learning journey/camps/excursions/sports events etc, communicate with our parents and school community in newsletters and on classroom seesaw.

Our **Photographing, Filming and Recording Students Policy**, describes how we will collect and use photographs, video and recordings (images) of students. The policy also explains when parent/carer consent is required and how it can be provided and withdrawn.

**Please note** there are uses of images that do not require consent. These include curriculum-based activities (i.e. class work), identity management, managing behavioural and safety incidents, to support a student's health and wellbeing, and to provide individual feedback or communication to a student, their parents/carers and/or school staff. If you have any concerns about the use of photographs in our school, for example, due to safety or cultural reasons, please contact the Principal at Jacana School For Autism.

This **Consent Form** describes:

- situations where consent is required and seeks that consent
- how personal information will be handled in regard to privacy law
- ownership and reproduction of images

If you would like to withdraw or change your consent at any time, you must notify the Principal at Jacana School For Autism. If consent is withdrawn verbally, we will make a written record of this. Please note, it may not be possible for the school to amend past publications or to withdraw images that are already in the public domain.

We will provide an annual reminder to parents about our **Photographing, Filming and Recording Students Policy** via the school newsletter. We will also notify parents when implementing software that may include photos of students, giving parents an opportunity to discuss any concerns or preferences.

This consent form applies to images of students that are collected and used by our school. We ask that parents/carers, students and invited guests do not photograph, film or record school performances, sporting events and other school activities. We ask that images of students are not publicly posted (e.g. to a social media account) without the permission of the relevant parent/carer.

## Privacy

---

Photographs, video and recordings (**images**) in which your child is identifiable are considered 'personal information' under Victorian privacy law. This means that any images of your child taken by the school may be a collection of your child's personal information. The school is part of the Department of Education (**the department**). The department values the privacy of every person and must comply with the *Privacy and Data Protection Act 2014* (Vic) when collecting and managing all personal information. ## Ownership and reproduction

Copyright in the images will be wholly owned by the school. This means that the school may use the images in the ways described in this form without notifying, acknowledging or compensating you or your child.
